Grants of up to \$2,000 per project may be awarded to teachers for use in the implementation of an educational based project to be completed with students in **Grades 6-9**.

Deadline: **September 30<sup>th</sup>, 2019**

## Grant Criteria

The Corporate Social Responsibility (CSR) Committee will base their selection on a variety of criteria including:

- It must benefit the school community, not small groups of students.
- The project should enhance the social and environmental responsibility within the climate of the school.
- This Grant is currently made available to active NSTU teachers members and members of PSAANS.
- A cheque presentation **shall** take place at the school during a meeting of staff, to be arranged in conjunction with the successful applicant.
- Grants up to \$2,000 per project may be awarded, the total amount for all project grants will not exceed **\$12,000 per calendar year**.

## Grant Description

- Costs associated with in-school presentations and guest speakers will not be considered.
- Costs associated with individual team sports.

## Additional Grant Information

- A written midterm report is required to be submitted to the CSR committee. Pictures would also be useful.
- Visual displays associated with the project are to include acknowledgement of the support provided by the TPCU.
- Approval of grants shall be limited to one grant per person per school year.
- Successful applicants will receive a cheque payable to the applicant's school. Copies of receipts are to be submitted to the CSR Committee upon expenditure of these funds.
- Material purchased with funds will remain the property of the school.
